Work with Towaoc K-12 education department to transport kids to and from Cortez again

70% of our students are "chronically absent" due to family transportation issues

Saturday April 15th 8:30-1:30 Board Retreat - UIP, Succession work, CSI visit - At the UMU Casino, including catering (many thanks!) - in the little buffalo room

Grant updates - \$1.5mil for Ute Language over the next 5 years - we're likely to get it; Pinon Project collaboration for after school programs

We'll transition progress monitoring tools from AimsWeb into DIBELS at the end of the year, consider STAR (used at SUIMA) - DIBELS will compare to our local population in RE-1

Lots of upcoming events at KCA this Spring

FY23 Q3 report - comparison from last FY to this FY (apples to apples comparison), we have more spending to do now in Q3, we'll need to roll some grants over where we can

TABOR discrepancies, increase this year; SPED reserve increased as well
