Ceriss – financial report – FY24 actual through February, nothing new to report from the last finance meeting, we're less behind than previous years, new grants picked up in January and February

## · Principal report

 Staffing – hired 2 new people, paraprofessional and college and career development specialist, have an application for 4<sup>th</sup> grade teacher with ELL/ ESS certs, PE part time as well

2. Facilities – payment to get a basketball court built, finish payment to Weemenuche in the modular, \$2mil grant from CO senate opportunity (looking into transportation, up to 3 vehicles, 15 person vans); flood repair in the modular is almost complete; windows covered with shatterproof safety film on both buildings; looking at adding irrigation for gardens in the back

3. Testing – CMAS is coming for  $3^{rd}$  grade, required trainings done, Danny is the administrator, tests are ordered, all paper testing

Ute day celebrated today because we aren't in school tomorrow (3/15), this is a tribute to our school's mission; taking more field trips for land based learning is difficult to balance with rigorous instruction for high achievement
